

U.S. Direct Loans – Statement of Borrower Loan Confirmation

Instructions

1. Review your loan period and the loan amount you have been assessed for in the Cost of Attendance and Estimated Direct Loan Information email.
2. Complete this form and submit it via [MacDrive](#). The recommended deadline to submit is August 1.

As a borrower, you have the right to accept or decline all or part of your loans. You do not need to accept the entire loan amount being offered to you. We recommend that you borrow an amount based on your needs. If you don't accept the full amount of the loan that you're eligible for right away, you can request to borrow more, up to what you have been initially assessed, at a later time.
